## Vendor Packet

**38th Annual Koi Show

Rental fees for booth space(s) are listed below. Each space is approximately 10' by 10'. Please note, a 10x10 space holds one show tank. A 20x10 space can hold three 6' show tanks. Availability will be based on receipt of completed reservation forms. As you will note, there is a substantial cost saving if paid by June 30<sup>th</sup>, 2018. Merchandise in lieu of payment will NOT be accepted. **Vendor Booth fees must be paid at the time of reservation.**

Booth rental fees include a table, 2 chairs and electricity. Additionally, if a wet vendor, consider participating in the Vendor Koi Show which takes place on Friday the 27<sup>th</sup> of July at approximately 6pm (please see Vendor Koi Show Registration Form). Please join us for the Friday evening BBQ, July 27<sup>th</sup>, where we will announce the winners from the Vendor Koi Show. Fish vendors may rent 6' show tanks at an additional cost of \$40.00 per tank and \$20.00 per aquarium. Security will be provided the evenings of Thursday, Friday and Saturday July 26<sup>th</sup>, 27<sup>th</sup>, and 28<sup>th</sup>.

**All vendors driving must provide their own nets, tubs, chemicals, air, canopies, and extension cords and set up. Payment is non-refundable after July 1st.** If you are flying and unable to bring all equipment please let us know, so we can organize an air pump, canopy, net, bowl, transportation, and other items if necessary. For this service price will be on individual basis by what you require.

No sale of food for human consumption will be allowed from vendor booths. Any raffles other than those sponsored by the N.W.K.G. Club must be approved in advance by Daren Beck, 2018 Show Chairman. Dealers may begin set up after 8:00 am PST on Friday July 27<sup>th</sup>, 2018. Teardown must be complete by 7:00 PM on Sunday July 29<sup>th</sup>

## 2018 Vendor Koi Show Announcement and Rules

Cost is **\$30** for **3 Koi maximum and minimum**. Please submit payment for Vendor Show prior to judging on Friday July 27<sup>th</sup>, 2018.

**Any variety is welcomed** including Longfins (Longfins are measured from nose to base of tail)

### Size Classes

- Size 1= under 10"
- Size 2= 10"-16"
- Size 3= 16"-20"

### Awards

- Grand Champion (any size, any variety)
- Grand Champion B (Any size, non Gosanke)
- Reserve Grand Champion (Any size, any variety)
- Baby Champion (size 1, Any variety)

### Rules

- 1) Vendors must submit payment prior to judging.
- 2) Only 3 koi may be entered by each dealer.
- 3) Vendors must be present for judging. Vendors need to handle their own koi for the judges, including netting and bowling. Please be respectful and quite when judges are present.
- 4) Accurately measure your koi before the show. NWKGC reserves the right to spot check size with a sanitized measuring device or tank.
- 5) Please have under 10" koi in a bowl (floating in the tank is fine) ready for the judges to view once judging has commenced. We will confirm size judging order prior to judging.

### Requests

- 1) Please supply a picture of the winners or request to have a picture taken.
